2025 - VENDOR AGREEMENT

As a condition of participation in the Annual Collegeville Fire Company Main Street Car Show (the "Event") the undersigned vendor agrees to the following:

- This Event shall take place on August 10, 2025, at the following location: Main Street, between ^{3rd} Avenue and ^{9th} Avenue Collegeville Borough, Montgomery County, Pennsylvania 19426
- 2. Vendor applications will only be considered if completed in full. Fees are to be paid in full **prior to** the Event date and are non-refundable.
- 3. Collegeville Fire Company (CFC) does not guarantee a particular number of attendees or exhibitors at this Event.
- 4. Tables and chairs are available to be rented from CFC at a rate of \$11 per 8-foot table, \$12 per round table and \$1 per chair Please contact: <u>rentals@collegvillefire.org</u> for this. ** **Table and Chair rentals should be made one week in advance of Event.** **
- 5. Vendors shall, at all times during the term of this agreement maintain such liability insurance as is required by law and will produce a copy of such liability insurance certificate or declarations page if requested by the CFC Car Show Committee.
- 6. Vendors shall indemnify, defend and save the Collegeville Fire Company No. 1, the Borough of Collegeville and Ursinus College, harmless from and against all claims, losses, costs and liabilities arising out of the damage to property, or injury to, or death of persons (including the property and persons of the parties hereto, and their agents, subcontractors and employees) in connections with the Vendor's participation I the Event.
- 7. In recognition that there may be some risk, injury or property damage in such an undertaking at the Event, the undersigned, Vendor does not forever discharge, release and hold harmless the Collegeville Fire Company No. 1, the Borough of Collegeville and Ursinus College, and any and all of its members, officers, employees, agents and/or sponsors, from any and all manner of action or damages, claims arising from any loss or damage to the person or property of the undersigned while participating in this Event and thereby consent to the enforcement of all rules regulations of the Event. Neither CFC nor the Borough of Collegeville, and Ursinus College will assume any responsibility for personal injury, theft, fire or breakage to you or your merchandise. Further the vendor shall defend any action so asserted or maintained arising out of any action taken by the vendor, his or her employees or agents.

- 8. All items sold, represented or distributed are subject to approval of the CFC Car Show Committee.
 - a. Any vendor wishing to sell sealed bottles of wine, beer or alcohol, must contact the car show committee at 34carshow@collegevillefire.org to review licenses, insurance and permitting as is required by Collegeville Borough, Montgomery County and the State of Pennsylvania. In Pennsylvania, the sale of alcohol by anyone is prohibited unless the seller holds a valid license or permit issued by the PLCB.
 - b. No flammable items or hazardous materials will be permitted at the CFC Car Show.
 - c. No weapons, controlled substances or similar materials will be permitted at the CFC Car Show.
- 9. Vendors shall continually police their area for safe and sanitary conditions. At the conclusion of the Event, each vendor shall be responsible for his/her own trash removal and shall restore the area to acceptable condition, as inspected by the designee of the CFC Car Show Committee. Vendor's trash should be placed in a trash bag, secured tightly and left at a place to be designated by a member of the CFC Car Show Committee.
- 10. The Car Show will open for early set-up Sunday, August 10, 2025 @ 7:00 am.
- 11. All Vendors must enter Main Street via W 4th Avenue from Park Avenue.
